511.1 Import Full Containers

Standard FREE storage for import full containers has been increased from 10 days to 14 days.

Standard FREE storage for export full containers has been increased from 7 days to 10 days.

BREAK-BULK CARGO FREE TIME AND STORAGE RATES

Effective November 1st 2008, following amendments will be made to the Free Time and Storage Charges applied for all General Cargo at Jebel Ali and Port Rashid. FCL CONTAINERS FREE TIME AND STORAGE RATES

Effective November 1st 2008, following amendments will be made to the Free Time and Storage Charges applied for all FCL import containers at Jebel Ali and Port Rashid. These measures have been necessitated to increase the available yard space and by that to improve the overall productivity of our container terminals.

In the view of above procedural change, all traders or their agents are hereby advised to please clear their cargoes within 3 months from the date of discharge. After exceeding 3 months time in the Port, DP World and Dubai Customs reserve the right to include these consignments in public auction.
